Regent Rich Boehne, Chair, called the special meeting of the Board of Regents to order at 12:30 pm, Monday, January 9, 2023.

#### A. Executive Session

Regent Cori Henderson seconded Chair Boehne's motion for the Board of Regents to go into Executive Session pursuant to KRS 61.810(1)(f) in order to discuss an employee personnel issue relating to possible appointment of an employee. **Motion carried.** 

No other matters were discussed.

#### **B.** Open Session

# BOARD OF REGENTS RESOLUTION INTERIM PRESIDENT ELIGIBILITY FOR PERMANENT POSITION

WHEREAS, the Board of Regents is evaluating the terms of appointment of an interim president and will determine the process for recruitment and selection of the next permanent president of Northern Kentucky University; and

WHEREAS, the Board now must resolve whether the interim president will be eligible to serve in the permanent position.

NOW, THEREFORE, BE IT RESOLVED that the Board of Regents has determined that the interim president will be permitted to apply for the position and, if selected, to serve as the institution's next permanent president.

Regent Zapp seconded Regent Ward's motion that the interim president be eligible to serve in the permanent position.

#### **Executive Session**

#### Board of Regents Resolution Appointment of Interim President

NOW, THEREFORE, BE IT RESOLVED that the Board of Regents hereby appoints Bonita J. Brown as interim president of Northern Kentucky University, effective January 18, 2023.

BE IT FURTHER RESOLVED that Board Chair Richard A. Boehne is hereby authorized to negotiate and execute such agreements and other documents as are appropriate to effectuate the appointment of the Interim President.

## Regent Working Group for Presidential Search

Chair Boehne brought forward for discussion the presidential search and spoke about the first steps in the process, noting that today is an important day for NKU, not only because we're celebrating the appointment of an interim president to lead us through this period, but also because we're taking our first steps in a process that will result in selection of our next permanent president – the seventh president of Northern Kentucky University.

#### • College of Informatics Reorganization

College of Informatics Dean Kevin Kirby and a team of faculty and students presented on the reorganization of the college into two new schools.

Scott Patton, Director of University Housing and Dr. Eddie Howard, Vice President for Student Affairs and Enrollment Management provided an update on University Housing.

**Joint Finance & Policy Committee Meeting Summary:** Board Secretary Williams provided a summary of the presentations given at the Joint Finance & Policy Committee Meeting held earlier in the day. These presentations included discussions on the proposed reorganization of the College of Informatics from three academic departments to two schools, the *School of Computing and Analytics* and the *School of Media and Communication;* an update on University Housing; and an update on the progress of the Repositioning Plan.

Audit & Compliance Committee Meeting Summary: Board Secretary Williams provided a summary of the January 17 Audit Committee Meeting where Director of Financial and Operational Auditing, Larry Meyer provided updates on internal audit reports issued since the last committee meeting, audits in process, and the search for the next external audit firm and Grant Garber, Vice President for Legal Affairs and General Counsel, provided updates on the work of the staff compliance working group and the upcoming annual compliance training. At the conclusion of the open meeting, members of the committee had the opportunity to meet privately with Grant and Larry.

#### **Presidential Comments:**

Good afternoon.

I want to start by thanking the Board of Regents for selecting me for this opportunity. I am honored and excited to be of service to NKU. I am also grateful to the Board as they have been working very diligently behind the scenes on numerous matters to ensure that NKU remains connected to its mission and its place in the region. Thank you for all that you do.

In my role of VP and CSO, I have been privileged to work with many of you across the campus on our strategic plan, Success by Design, so I am very excited about continuing to work with you in this new role.

Board of Regents Meeting January 18, 2023

I want to start by thanking each of you for all that you have done over the past two years and in particular, the past few months. I know it has been difficult and challenging at times to deal with uncertainty, but NKU is known for its resiliency and how it supports students in reaching their academic goals. I have seen many of you go above and beyond to get the work done and to support our students.

And we have seen the results:

Our overall retention rate is up to 77.5%--up from 70% during COVID--2021.

Our 6-year graduation rate has increased to 51%--up from 49% during COVID.

If you recall--we just graduated more than 1300 students this past December.

We are doing the hard work. But while we have had successes, there is more to be done.

I wish I could tell you that things were going to immediately be different going forward, but I think we all know that we still have difficult work to do.

As we work through our finances and our enrollment challenges, I ask for your support and your patience. There is a lot to work through. And it won't be easy.

As you can imagine--I have not yet determined any plans for my tenure, but I do know that we will need to do 3 things:

Focus on stabilizing our campus—budget, processes, policies and procedures.

I want us to build on our sense of community—bring back vibrancy to campus and build new connections all across campus and to refocus on our purpose: Student Success and being a steward of place for this region.

I will be on tour and holding listening sessions all across campus in the near future, and I really want to hear your thoughts and your ideas —and I want you to be thinking about what you can do in this moment. —Staying the same, or maintaining the status quo is not an option. So be ready to embrace change.

NKU has a special place in the hearts of many people in this community, the region and across the state, and we are vital to the growth of this region.

Together we can continue to exemplify the NKU spirit while, at the same time, positioning ourselves for the new realities we are faced with.

I am excited and humbled and cannot wait to work with this amazing campus. Thank you.

During the September 1, 2022, through October 31, 2022 time period, 10 grants were awarded. The total amount of money awarded was \$3,699,987. For the fiscal year 2022-23, the cumulative total number of grants awarded was 33, totaling \$11,014,548.

#### FACILITIES MANAGEMENT REPORT

#### 1. Herrmann Science Center Expansion

This project envisions construction of additional teaching and research labs in biology, chemistry, biochemistry, physics, geology and engineering technology in an 87,000 square foot addition to the 175,131 square foot Dorothy Westerman Herrmann Science Center. The project may be an addition or it could be a freestanding building adjacent to the existing Science Building. The budget includes funding to undertake limited renovations in the existing building. Programing includes moving CINSAM and Kentucky Center for Mathematics into the building. The project may include implementation of stand-alone hot water or geothermal heating for this building. The program verification phase was completed in February and schematic design is underway.

Scope: \$79,900,000

Fund Source: State Bonds

Anticipated Completion: Fall 2026

#### 2. Fine Arts Floor Heaving and HVAC Replacement (AP)

This Asset Preservation project includes demolition of approximately 16,000 square feet of heaved floor slab on the first floor of the Fine Arts Center, and reconstruction; installation of a new fire alarm system; and, total replacement of the building's HVAC system. Design work is underway, with construction anticipated to begin in summer 2023.

Engineers: CMTA, THP and Terracon

Contractor: TBD Scope: \$13,240,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: TBD

#### 3. Power Plant Boiler Controls Upgrade (AP)

Asset Preservation funds will be used to replace obsolete dampers, controls, linkages and valves on winter steam boilers #2 and #3, resulting in increased energy efficiency and reliability. Materials are on site; work is underway and should be complete in summer 2023.

Contractor: Ware Scope: \$380,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion:** Summer 2023

#### 4. Nunn Hall Floor Heaving/Restrooms and HVAC Renewal (AP)

As an Asset Preservation project, this includes demolition of approximately 8,000 square feet of heaved floor slab on the first floor of Nunn Hall, and reconstruction. Scope of work includes replacement of the restrooms on all five floors and upgrades to the HVAC system. Design work is underway, with construction anticipated to begin in summer 2023.

Architect: Luminaut

Engineers: CMTA, THP and Terracon

Contractor: TBD Scope: \$8,800,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: TBD

#### 5. Replace Norse Commons Rooftop HVAC Units (AP)

The Asset Preservation pool will fund replacement of Norse Commons rooftop cooling/heating units. They are in poor condition and overdue for replacement. New units are on order from Trane with a potential summer 2023 delivery and installation.

Contractor: TBD Scope: \$350,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion:** Summer 2023

#### 6. Replace Maintenance Building Rooftop HVAC Units (AP)

Maintenance Building rooftop HVAC units are in poor condition, increasingly unreliable, and overdue for replacement, which is necessary. The plan is to purchase these units from Trane and bid their installation.

Contractor: TBD Scope: \$175,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: TBD

#### 7. Regents Hall Bleachers and Floor Replacement (AP)

The original, bench-style bleachers on the south side of Regents Hall are in poor condition. The playing floor dates to the early 1970s and is overdue for replacement. With this project, the bleachers will be replaced and a new playing floor will be installed.

Engineer: Elevar Contractor: TBD Scope: \$600,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion:** Summer 2023

#### 8. Fine Arts Freight Elevator Modernization (AP)

The Fine Arts freight elevator requires modernization to ensure reliability and safe operation. The electrical and mechanical components are worn and misaligned, effecting reliability and consistency of performance, resulting in intermittent malfunctions. The elevator will not function at the first-floor level of Fine Arts. The project is in the design phase with IMEG.

Engineer: PEDCO Engineering/IMEG

Contractor: TBD Scope: \$380,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: TBD

## 9. Rebuild Power Plant Cooling Towers (AP)

Six (6) Power Plant cooling towers will be rebuilt using Asset Preservation funds. Scope of work includes removal and replacement of all fill media, including cleaning and sealing of the towers. This is a critical deferred maintenance need. Work started in November but was on hold due to cold weather. Three of the six cooling towers are complete. Work resumed this month, with an expected completion date of summer 2023.

Contractor: ServiceTech

Scope: \$626,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion:** Summer 2023

#### 10. Steely Library Generator and Switchgear Replacement (AP)

Steely Library's generator is being replaced because it is at the end of its useful life and will be replaced. The generator provides critical back-up power in the event of a power outage. The generator was ordered through Cummins and is scheduled to ship in October 2023. Generator installation will be scheduled once delivery is confirmed. The switchgear portion of the project is in design with KLH Engineers.

Engineer: KLH Engineers (Switchgear)

Contractor: TBD Scope: \$350,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

#### 11. Maintenance Building Roof Restoration (AP)

The Maintenance Building roof was installed in 1996, estimated to last 20 years. The roof is showing signs of stress and has minor leaks. This project will restore the roof by replacing insulation (where necessary) and installing a new protective membrane and gravel. The roof will have a 10-year warranty.

Roof restoration, rather than complete replacement, extends roof life, saves resources, reduces replacement costs by up to 50%, and reduces landfill materials up to 10%, among other benefits.

The installation contract was awarded to WTI-Tremco. The cost, \$381,000, was less than anticipated. Start of on-site work was delayed until March 2023 due to cold weather.

# 12. <u>Business Academic Center and Mathematics-Education-Psychology Center Fire Alarm System Replacements (AP)</u>

The fire alarm system and devices in these two buildings are in critical need of replacement. This project includes installation of "smart" devices that will bring the systems in both buildings up to code. This is a critical life safety project. Materials have been ordered and work is expected to begin in spring 2023.

Contractor: Ohio Valley Electric/IPS

Scope: \$540,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: Fall 2024

#### 13. Campbell Hall Return Air System Upgrade (AP)

The return air system in Campbell Hall is in poor condition. New equipment will ensure proper airflow, enhance indoor air quality and improve occupant comfort. This project is in the design phase.

Engineer: CMTA Contractor: TBD Scope: \$450,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion: TBD** 

#### 14. Nunn Hall Façade Repairs (AP)

The exterior concrete façade of Nunn Hall needs will be assessed at locations where the concrete is spalling; these spalls are caused by rusting of the steel reinforcing bars. The project includes condition assessment by a forensics structural engineer, and completion of recommended repairs, caulking, sealing and waterproofing as may be required. To avoid potential for injury, the project includes the immediate removal of loose concrete where freeze/thaw has damaged the concrete surface.

Engineer: THP Limited, Inc.

Contractor: TBD Scope: \$235,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

#### 15. Kentucky and Commonwealth Halls / Emergency Generator Replacement (AP)

The emergency generator serving Kentucky and Commonwealth Halls is original (1982) and is beyond its useful life. The generator provides critical back-up power in the event of a power outage. The new generator has been ordered from Cummins and is expected to be received in November 2023. Installation will follow.

Contractor: TBD Scope: \$105,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: Winter 2023

#### 16. FY 2023 Replace Flooring/Main Campus (AP)

Interior flooring at main campus buildings is to be replaced based on assessments of existing conditions including safety, deterioration, damage and age.

Contractor: TBD Scope: \$150,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion: TBD** 

#### 17. Refurbish Interior Landrum Stairwells (AP)

The interior of Landrum's two stairwells are scheduled to be refurbished in summer 2023. Work will include wall and handrail patch/paint, ceiling removal/replacement, HVAC unit and lighting replacement, and possibly, replacement of doors exiting stairs at each floor.

Contractor: TBD Scope: \$345,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion:** Summer 2023

#### 18. Regents Hall Generator & Switchgear Replacement (AP)

Regents Hall's emergency generator and switchgear are original to the building (1972) and in critical need of replacement. The generator provides critical back-up power in the event of a power outage. The generator has been ordered through Kohler and is scheduled to ship in November. The switchgear portion of the project is currently in design with KLH Engineers.

Engineer: KLH

Scope: \$625,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

#### 19. University Center Replace Switchgear (AP)

The switchgear in the University Center, original to this 1977 building, is beyond its useful life expectancy and needs to be replaced. This project is currently in the design phase through KLH Engineers.

Engineer: KLH Contractor: TBD Scope: \$330,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

Anticipated Completion: TBD

#### 20. Fire Alarm Cabling Upgrades (AP)

The fiber backbone project will replace aged fiber connections between and within buildings as well as creating redundant fiber capacity needed for future use, such as fire alarm panel connectivity. The project also includes relocation of the main network equipment in Norse Commons, to better meet system requirements, as well as network monitoring software. Buildings included in the project are Business Academic Center, University Center, Student Union, Griffin Hall, Norse Commons and the Maintenance Building.

<u>Contractor</u>: GBS-Inc. Scope: \$100,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

**Anticipated Completion: Spring 2023** 

#### 21. Steely Library Glass Elevator Modernization

Steely Library's glass elevator requires modernization to ensure reliability and safe operation. The electrical and mechanical components are worn and misaligned, affecting reliability and consistency of performance, resulting in intermittent malfunctions. This project is in the design phase.

Engineers: PEDCO Engineering/IMEG

Contractor: TBD Scope: \$395,000

Fund Source: Construction - AP Funds (86.96%) and NKU Match (13.04%)

#### 22. NPHC Plots

The NKU chapter of the National Pan-Hellenic Council, the governing body for the nine historically African American collegiate Greek- lettered organizations, is working to create a monument to honor the chapters currently on campus while acknowledging the Divine Nine of the National Pan-Hellenic Council.

Brownstone Design led the design process, which included student input. The site located on the north side of the Student Union near the West Quad, alongside a major pedestrian path, will include donor recognition pavers, an etched monument stone and aluminum banners.

Pavers and bricks are installed. The permanent metallic banners are in place and landscaping is complete. The granite monument, the last piece of the Plot's design, is in process of being cut and etched. A completion date has not yet been confirmed.

#### 23. Concrete Sidewalk/Plaza Repairs (AP)

This project encompasses various concrete repairs and replacements to exterior concrete plazas, stairs, retaining walls, etc. Work will occur in all areas of campus, and will begin in summer 2023.

Contractor: TBD Scope: \$500,000

Fund Source: AP Funds (86.96%) and NKU Match (13.04%)

#### 24. University Suites Exterior Façade Repairs

Water infiltration has become a significant problem at University Suites. A façade condition assessment has been completed. The structural engineer is preparing bid documents based on recommendations included in the assessment report. This project is currently in the design phase.

Engineer: THP Contractor: TBD Scope: \$450,000

Fund Source: NKU Bonds – Supported by Housing Bond Revenue

**Anticipated Completion:** Summer 2023

#### 25. Various Upgrades at Callahan Hall

Bond funds and housing operating funds have been set aside to accomplish various upgrades at Callahan Hall:

1) Completed: Interior painting.

- 2) Completed: Removal of poor-condition asbestos flooring in the stairwells; repair and sealing of concrete stair treads; and, application of non-slip tape on stair nosings.
- 3) Construction underway: Renovation of the building's main entrance at H-Wing first floor is underway to improve functionality and aesthetics of the entry experience. The adjacent and vacant room H102 will become a 24x7 fitness center for the East Village; a new reception desk and lobby will be constructed at the entry; and, a new level of card access-security doors will increase security between public and resident spaces. In addition, 14 sets of double doors to resident wing levels 2 and 3 will be replaced due to the doors' existing condition. A spring 2023 completion is anticipated.

# **DIVISION OF ACADEMIC AFFAIRS**

The Division of Academic Affairs created an Organizational Unit named Integrative Studies in the College of Arts and Sciences effective 07/01/2022. This addition along with a new Fund Center will help manage and allocate costs associated with Integrative Studies including faculty and staff who have responsibilities related to Integrative Studies. This organizational unit addition will not increase costs. The retroactive effective date was necessary to facilitate system updates associated with courses and other curriculum changes.

\*REVISED LANGUAGE - At the January 18, 2023 meeting, this was incorrectly listed as a *Department*, rather than an *Organizational Unit*.

### **BACKGROUND:**

The University has a broad range of existing academic support services; however, many of these units exist in various locations. The creation of an Academic Commons would centralize these related student-learning resources. The Academic Commons will make these resources convenient and accessible to all learners as well as enhance classroom experiences (regardless of modality) and promote the free exchange of ideas.

The Academic Commons at Northern Kentucky University would consist of a coordinated group of student-focused learning resources designed to give students convenient access to academic support services in a student-friendly environment designed to enhance access and collaboration. The Academic Commons would bring together units that complement the classroom learning experience and empower students to achieve their academic goals.

The Academic Commons, comprised of spaces, tools, and support for learning and teaching, peer-to-peer collaboration, and co-curricular support for students, would include three clusters of support units:

# **RESOLUTION**

### CREATION OF THE ACADEMIC COMMONS

WHEREAS, the University currently operates many academic support services units across campus;

WHEREAS, consolidation of these units into a single, centralized location and resource will enhance student success, improve communication between support units, and foster a sense of community on campus;

WHEREAS, the Board of Regents has the authority to establish centers, institutes, and similar University academic units; and

WHEREAS, the proposed Academic Commons will significantly enhance the academic support resources that the University offers to its students.

BE IT RESOLVED that the Board of Regents approves the creation and establishment of the Academic Commons at Northern Kentucky University.

That the Board of Regents authorize the administration to execute a lease of the Civic Center building to the Commonwealth of Kentucky, for use by the Justice and Public Safety Cabinet.


# **BACKGROUND:**

The Civic Center building is a two-level, 19,073 square foot facility located at 175 Johns Hill Road, just south of the NKU Soccer Stadium (see below). The Civic Center was built in 1978 and originally was home to Highland Heights' city operations and police department. The University acquired the facility from the city in June 2010 for a nominal payment, and the building has been essentially vacant since that time, periodically serving as a storage location. The University has no foreseeable uses for the building, which would need significant restoration and renovation if it were to be occupied.

The Kentucky Division of Real Properties has approached the University to inquire about possible space to house a Northern Kentucky Medical Examiner's office. After several months of discussions, the Justice and Public Safety Cabinet has expressed a desire to lease the Civic Center building for this purpose.

The proposed lease would be for a 25-year initial term, with a ten-year renewal, at market-based rental rates. Substantial renovations to the Civic Center would be required before the Cabinet can use the space, and to incentivize the transaction, the University would manage the renovation work and would fund up to \$3.75 million in renovation and upfit costs, with the Cabinet responsible for any additional amounts. After occupancy, the University would continue to perform maintenance and repairs on building envelope and systems.

Staff recommend approval of the lease, which creates both a revenue-generating opportunity for the University from an otherwise unusable building and a needed space for important government functions.

### RESOLUTION

#### LEASE OF CIVIC CENTER BUILDING

WHEREAS, Northern Kentucky University owns the two-story building located at 175 Johns Hill Road, known as the Civic Center building, which has been vacant since 2010 and has no foreseeable University use;

WHEREAS, the Commonwealth of Kentucky, through the Justice and Public Safety Cabinet, has expressed interest in a long-term master lease of the Civic Center for an initial term of twenty-five years, plus a ten-year renewal, at market-based rental rates;

WHEREAS, to facilitate the renovation, the University would contribute up to \$3.75 million in funds toward design and construction costs, with any excess renovation costs to be the responsibility of the Justice and Public Safety Cabinet; and

WHEREAS, pursuant to KRS 164A.575(8) and other applicable authority, the Board of Regents may authorize the lease of University real property; and

WHEREAS, the transaction described herein is in the best interests of the University.

BE IT RESOLVED that the Board of Regents approves the proposed lease of the Civic Center building to the Justice and Public Safety Cabinet and authorizes the President to negotiate further reasonable terms and execute an appropriate lease and other documents necessary to accomplish the transaction.

That The Honorable Aftab Pureval receive an Honorary Doctor of Laws Degree. The recommendation comes from Judith Daar, the Ambassador Patricia L. Herbold Dean of Chase College of Law.

### **BACKGROUND:**

Aftab Pureval is the 70th Mayor of Cincinnati. He was raised in Southwest, Ohio, the son of first-generation Americans. He is making history as Cincinnati's first Asian American Mayor. As Mayor, he is committed to serving all 52 Cincinnati neighborhoods as well as the region. He has made equitable economic growth a top priority of his administration, as well as a comprehensive reform and improvement of public safety, affordable housing, and environmental action.

Early in his career, Mayor Pureval lived in Washington, D.C., where he worked as an associate at White & Case LLP in the area of anti-trust litigation. He returned to Hamilton County, Ohio, in September 2012 to work as a special assistant U.S. attorney for the United States Department of Justice. He started in November 2013 as legal counsel for Procter & Gamble, and was included on *Cincinnati Business Courier*'s 2015 Forty Under 40 list.

Mayor Pureval served as Hamilton County Clerk of Courts from 2016 to 2021, a position in which he acted as the official record keeper and agent of Hamilton County's Adult Justice System. During his tenure, Mayor Pureval brought modern and professional reforms to the Clerk's office. He paid a living wage to all employees and become the first county officeholder in Ohio to offer comprehensive paid family leave. By ending nepotism, by cutting waste, and by making the office more professional, he saved taxpayers millions of dollars.

Mayor Aftab graduated from The Ohio State University and the University of Cincinnati for law school. He resides in Clifton with his wife, Whitney, and their sons, Bodhi and Rami.

That Mr. Richard "Dick" Murgatroyd receive an Honorary Doctor of Education Degree. The recommendation comes from Eric Gentry, Vice President for University Advancement, and has been approved and endorsed by the Provost and Executive Vice President for Academic Affairs.

# **BACKGROUND:**

In recognition of his dedication to education and civic prosperity in our region, including his devoted service to and work at Northern Kentucky University, Richard "Dick" Murgatroyd has been recommended as an honorary degree recipient at the May 2023 Commencement.

Mr. Murgatroyd is a long-time resident of northern Kentucky who has most recently served as the director of finance, operations and marketing for Visiting Angels in Southwest Ohio. His career leading up to this point has been marked by excellence through his foundational involvement and advocation for education at universities such as NKU, distinguished government positions as a former member of the Kentucky House of Representatives and as Kenton County Judge Executive, and his revered contributions to radio and broadcasting in Cincinnati.

The important work for NKU that Mr. Murgatroyd has done throughout the years is exceptional. Bringing his expertise in radio and broadcasting with him, he served as an NKU faculty member for 12 years. He was also a founding faculty member of our School of Media and Communications. Beyond his role as a faculty member, Mr. Murgatroyd has contributed much of his time and talent to NKU by formerly serving as a member on numerous boards, some of which include: NKU President's Council from 2003 to 2012, NKU Foundation Board from 1999 to 2011 (emeritus), Norse Athletics Board, WNKU Board and more.

His dedication to NKU goes beyond his service as a board member on campus. Mr. Murgatroyd has also been financially generous to NKU. In 2013, he established the Richard L. Murgatroyd Endowed Scholarship to support undergraduate students demonstrating academic achievement. The scholarship has since been amended to support academic-achieving undergraduate students who are also a part of the Pi Kappa Alpha Fraternity, the Eta Rho chapter at NKU, for which Mr. Murgatroyd himself had a hand in founding.

Civically, Mr. Murgatroyd has volunteered his time to many non-profit boards around the Greater Cincinnati and northern Kentucky area. He currently serves on the board of advisors for the Elsa Heisel Sule Foundation. Previously, his service has benefitted the region as he has held many board positions, including the former board president of The Point/Arc (emeritus), the former board president of the Northern Kentucky Heritage League, a former member of the Northern Kentucky Chamber of Commerce, a former board member of the Social Venture Partners of Cincinnati, a former board member for the Cincinnati Jazz Hall of Fame, a former board member for the Bluegrass Buckeye Charity Holiday Classic, and many more.

Mr. Murgatroyd has accomplished much in his lifetime and has been recognized for his excellence and service to his communities on multiple occasions. He is the recipient of many awards, including the 1999 NKU Lincoln Award, an Emmy Award for his work as a producer in broadcasting and television, the 2006 Silver Circle Honoree for the National Academy of Television Arts and Sciences, the 2012 Lifetime Achievement Award for the Eta Rho Chapter of Pi Kappa Alpha, the 2013 Clyde and Mary Middleton Lifetime Achievement Award, a member of the Northern Kentucky Sports Hall of Fame, a member of the Cambridge Schools Hall of Fame in his hometown of Columbus, Ohio, and much more.

Mr. Murgatroyd is and has been a mentor and role model for NKU students and an advocate for higher education for the entirety of his professional and philanthropic life. As an integral part of NKU's history and an outstanding advocate for any community he's a part of, Richard "Dick" Murgatroyd is an exceptional individual to recognize with an honorary degree at this spring's commencement ceremony.

- (4) The naming of an endowed LIFT scholarship to support students pursuing studies in physics with a preference for students pursuing studies in astronomy. "Hawkins Endowed Scholarship in Physics"
- (5) The naming of an endowed LIFT scholarship to support students who are music majors with a preference for students who are serving the Music Preparatory program as teaching assistants or junior instructors. "Hawkins Endowed Scholarship in Music"

#### **BACKGROUND**:

Naming actions in connection with private gifts are governed by NKU Administrative Regulation-II-4.0-2, section 2.2. NKU's Naming Policy provides for naming opportunities in consideration of a major contribution to the university. The policy allows flexibility in determining the level of contribution appropriate for each naming action, enabling each gift to be judged on its own merit.

After careful consideration by university officials and unanimous support by the University Naming Committee, it was recommended to offer the following naming recognitions.

(1) The university has received a gift that will support a scholarship for students who have declared a major or minor in the Department of English or are taking a study abroad course approved by the department.

Naming Recognition: English Study Abroad Endowed Scholarship

Carla Landon is on the Alumni Board of Directors and is very involved at NKU. She had a life-changing experience studying abroad and wants to support that for others.

(2) The university has received a gift that will support a scholarship for students enrolled in the Salmon P. Chase College of Law. The scholarship shall be awarded annually to a student who demonstrates high academic promise. There shall be a preference for students from Eastern Kentucky.

The Board of Regents Audit and Compliance Committee recommends that the Board of Regents authorize the administration to enter into a contract with the audit firm of Dean Dorton, LLC for the annual audit of the University's financial records for the fiscal year ending June 30, 2023. The contract cost for the year ending June 30, 2023 will be approximately \$103,000. This contract will allow for three one-year renewable options with the concurrence of both parties.

# **BACKGROUND:**

The University Audit Review Committee conducted a comprehensive review of the proposals received in response to the University's request for auditing services. The Audit Review Committee forwarded a report of their findings to the Board of Regent's Audit and Compliance Committee. It was determined that Dean Dorton, LLC was evaluated as the highest quality proposal.

The above recommendation is consistent with the committee evaluations and is supported by the Chief Financial Officer.

### RESOLUTION

# **EXTERNAL AUDIT FIRM**

WHEREAS, Kentucky law and the Bylaws of the Board of Regents require that an independent external auditor complete a financial audit of Northern Kentucky University each year;

WHEREAS, the University's most recent contract with an external audit firm has expired, and the University has conducted a competitive process to identify a new audit firm;

WHEREAS, based on that process, the Audit and Compliance Committee of the Board has recommended that Dean Dorton, LLC, serve as the University's external audit firm for up to four years.

BE IT RESOLVED that the Board of Regents approves selection of Dean Dorton, LLC, to serve as the external audit firm for Northern Kentucky University and authorizes the President to sign appropriate contracts to retain the firm.

That the Board of Regents approve the transfer of the NKU-owned 12" sanitary sewer line that extends along University Drive and Three Mile Road to Sanitation District #1 (SD1).

# **BACKGROUND:**

In 1982, the University constructed a sanitary sewer line along University Drive and Three Mile Road. After construction of this 5,260 foot line, sewage from the University and the NKU Foundation Research Park flowed to the west, to an existing SD1 line. As a result, the University disconnected its system from the Highland Heights sanitary system near Nunn Drive, which was approaching capacity at that time.

The sewer line extends from Nunn Drive at the east end to Gibson Lane at the west end, and has 22 manholes. The line is depicted in the attached map.

Currently, the University bears the cost and risk associated with operation and maintenance of the line, as well as the risk of line failures and overflows. The University also has experienced modest capacity challenges in connection with recent new campus construction projects.

SD1, the public sanitary and storm sewer utility serving our area, has offered to assume ownership of and responsibility for the sewer line, in exchange for payment by NKU of approximately \$35,000 to cover the cost of necessary minor repairs.

Staff recommends that the Board approve this transaction. By transferring ownership of the line, the University will avoid significant future costs and risks, and SD1 will be better able to manage capacity for the campus and surrounding area. Note that SD1 has plans to replace and upsize the center section of the line (shown in pink/red, under the interstate).

As part of this conveyance, SD1 also would require easements across and under University property to access, maintain, repair, operate, and periodically replace the line.

### RESOLUTION

#### TRANSFER OF SEWER LINE

WHEREAS, Northern Kentucky University owns a sanitary sewer line, constructed in 1982, that serves campus and runs approximately 5,260 feet along University Drive and Three Mile Road;

WHEREAS, the University currently is responsible for maintenance and repair of the sewer line, along with associated costs, and would be responsible for future necessary line overhauls and possible failures;

WHEREAS, Sanitation District #1, a public sewer utility with responsibility for sanitary and storm sewer service in northern Kentucky, has offered to assume ownership of and responsibility for the University sewer line, with a nominal payment from the University to cover the cost of short-term minor repairs; and

WHEREAS, the proposed transaction will allow the University to avoid costs and liabilities and is in the best interests of the University.

BE IT RESOLVED that the Board of Regents approves the conveyance of the sewer line described herein and authorizes the President to execute all documents necessary to accomplish the transaction, including easements reasonably required by Sanitation District #1 to access and perform related activities regarding the sewer line.
